I understand and agree that:

- 3. Both Parent(s), Guardian(s) and/or Participant hereby voluntarily release 2025 World Taekwondo Hanmadang, LLC, their agents or employees, and all other persons or entities from any and all liability, claims, demands, actions or rights of action, which are related to or are in any way connected with the Participant's participation in 2025 Kukkiwon World Taekwondo Hanmadang that may arise from or be related to any loss, damage, or injury, including death, that may be sustained by myself, my child or any personal property while participating in 2025 Kukkiwon World Taekwondo Hanmadang, programs and any and all other activities conducted and/or organized by 2025 World Taekwondo Hanmadang, LLC., including specifically but not limited to negligent acts or omissions of 2025 World Taekwondo Hanmadang, LLC their agents or employees, and all other persons or entities, for any and all injury, death and damage to myself, my child, any Parent or Guardian or to their property.
- 4. I further agree that if, despite this release, I or anyone on my or the minor child's behalf makes a claim against the 2025 Kukkiwon World Taekwondo Hanmadang or any Releasees, I will indemnify, save and hold harmless each of the Releasees from any litigation expense, attorneys fees, loss liability, damage or costs that may incur as the result of any such claim.
- 5. All information provided to the 2025 Kukkiwon World Taekwondo Hanmadang in my Coach's registration is valid and true.
- 6. I will not share my Coach's badge with anyone else to use for admission into the Anaheim Convention Center Arena, competition floor, Westin hotel, or other areas.
- I will pick up my Coach's Badge and wear it visibly at all times that I am at the Anaheim Convention Center Arena for the 2025 Kukkiwon World Taekwondo Hanmadang Thursday July 17 through Saturday July 19, 2025.
- 8. I will treat all participants, volunteers, parents, security, Organizing Committee members, and staff with respect and courtesy.

- 9. I will follow all of the rules and regulations of the 2025 Kukkiwon World Taekwondo Hanmadang including requests by members of the staff, Organizing Committee, and security.
- 10. I will complete the abbreviated Safesport review provided by the 2025 Kukkiwon World Taekwondo Hanmadang.
- 11. While I am on the competition floor I will stay with my athlete until he/she finishes the competition on the floor. While at the ring I will stay in the designated area for coaches or where directed by organizing committee members.
- I understand that the Coach's pass does <u>not</u> allow me to be on the competition floor at all times. I may <u>only</u> be on the competition floor when my athlete(s) are on the competition floor.
- 13. I will only enter the competition floor through the holding area or awards area with my athlete(s). I cannot enter the competition floor from the VIP section or any other area.
- 14. I will not go onto the competition mat unless given permission by a referee.
- 15. I will not disrupt competition.
- 16. I agree and understand that only certain events listed in the 2025 Kukkiwon World Taekwondo Hanmdang Rule are eligible for video protest. Further, I agree and understand that in order to be eligible to make a video protest I must attend the coach's meeting on Wednesday July 16, 2025 from 4:00 – 5:00 PM at the Anaheim Convention Center.
- 17. I <u>can</u> take pictures and/or video of my athlete while coaching. Official photographers for the 2025 Kukkiwon World Taekwondo Hanmadang have the authority to move me if necessary. I will comply with the Official Photographer's request.

I have read the above and understand and agree that failure to follow any of the above rules may lead to immediate dismissal from the 2025 Kukkiwon World Taekwondo Hanmadang, the Anaheim Convention Center Arena, the Westin Hotel, and any other event/location for the 2025 Kukkiwon World Taekwondo Hanmadang without any refund for any monies paid for myself, family, and/or students.
